### ABOUT BELLE MEADE

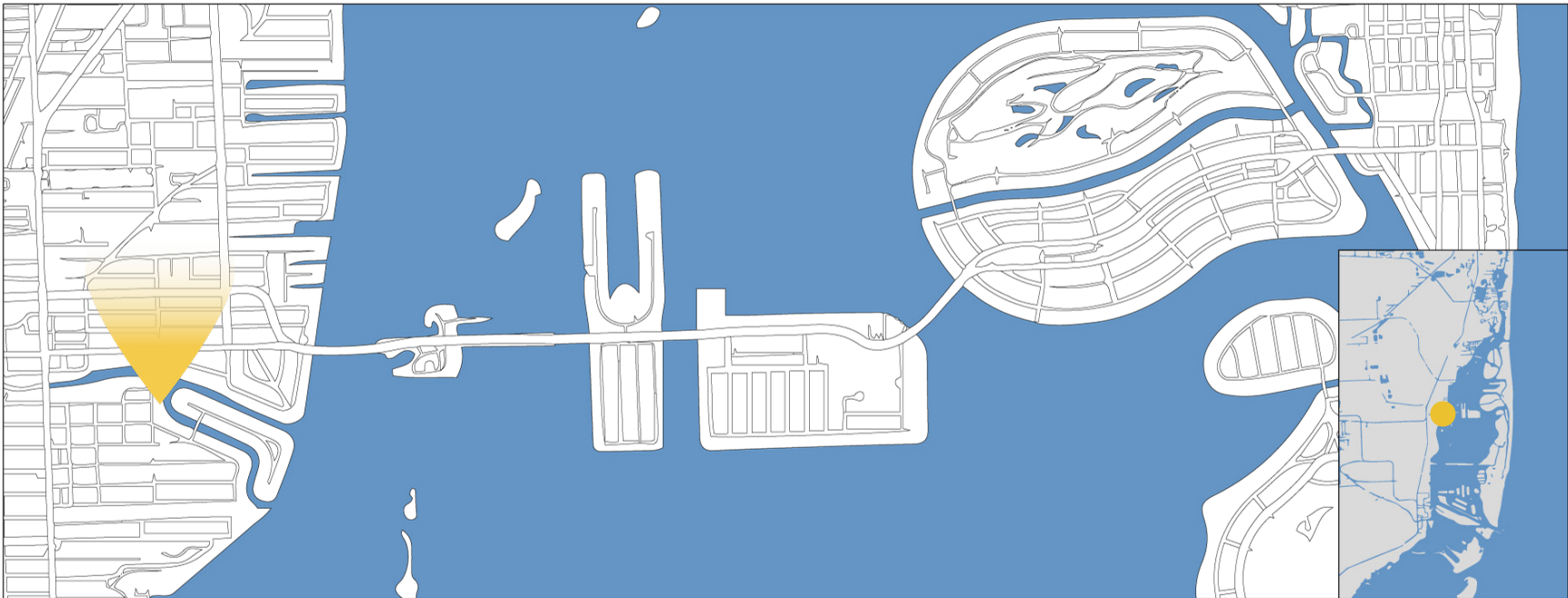
